The northern boundary of the southeast Florida region is at the St. Lucie Inlet in Martin County, so St. Lucie County is not included; however the issue of nearshore hardbottom being buried by beach renourishment occurs in southeast Florida as well. Incompatible uses of the coastal zone such as you've described often require compromise, and in the case of beach renourishment, typically it is allowed to occur but with mitigation for and monitoring of the affected habitat. Additionally, SEFCRI has developed Best Management Practices (BMPs) for coastal construction projects, such as beach renourishment, to minimize negative effects to coral reefs and associated resources which are available on our website at http://www.dep.state.fl.us/coastal/programs/coral/reports/
